Q3 (a) Accident investigation is carried out in order to determine the cause or causes of an accident so as to prevent future damage, injury or loss.

Discuss FOUR (4) initial steps in accident investigation.

(b) At near midnight, Raju was sleeping in an open area near the factory building. Specifically, the open area is at T-junction that is commonly used as a forklift path to load and unload the concrete blocks. There was poor lighting in that area. At around 11.55 p.m., a 7 ton forklift carrying 200 kilos concrete block turned into the T-junction and ran over Raju. The accident caused him succumbed serious injuries in several parts of his body. He was then brought to the hospital but died soon after he arrived at the emergency room. His colleagues reported that on the day of the accident, Raju was seen to be exhausted after working for more than 12 hours. He then felt asleep in the incident area after having his mid night supper. In the mean time, the forklift driver testified that though concrete block he was

carrying obstructed his vision, he was still driving the forklift. In addition to that, he was not familiar with the area where Raju was sleeping.
