- Q1 Laws can be classified in different categories.
 - (a) Explain the term criminal law and civil law.

- Q2 The National Policy on Biological Diversity (NPBD) exhibits the Malaysian Government's efforts in the conservation of biodiversity.
 - (a) NPBD 2022-2030 is the policy formed as part of Malaysia's response to the Kunming-Montreal Global Biodiversity Framework. Elaborate **FIVE** (5) emerging challenges in implementing NPBD 2023-2030.

- Q3 Management plans are an essential tool in managing any open space.
 - (a) In the context of biological diversity, describe a management plan.

(c) As a conservation officer, you are instructed to formulate a management plan for a protected area comprising a lake that has been a source of drinking water for the local community. The lake is surrounded by a reserved forest on one side and an oil palm plantation on the opposite side. For the initial step in formulating the management plan, demonstrate the roles of FIVE (5) stakeholders who are potentially involved in the management plan.

- Q4 Forest in Peninsular Malaysia is the habitat of a variety of wildlife and is home to the indigenous people or Orang Asli. Under the Aboriginal Peoples Act 1954, the Orang Asli hold legal occupancy rights in many protected forests. However, such rights can raise possible conflict between biodiversity conservation and natural resource utilization of the Orang Asli.
 - (a) By referring to any **TWO** (2) the relevant legislations, discuss how these legislations protect biodiversity while at the same time addressing the needs of Orang Asli.

(b) An Environmental Impact Assessment (EIA) document comprises of several components. If you are analyzing an EIA document on the development of an airport situated near a forested area, demonstrate FIVE (5) components you would be expecting to be in the document.
